**You Have A Voice In The Future
Of ATV Recreation.**

How Do You Want It?

It is important for ATV Minnesota, its members and member clubs to have a collective voice, communicated through our lobbyists to the State Legislature, to create laws that positively affect ATV recreation in Minnesota.

I attended my first Legislative Summit in 2008 as a new member of ATV MN. I found it to be a “first-step” meeting to help ATV MN members provide lobbyists Ray Bohn and Tom HackbARTH with a list of prioritized resolutions to move forward in the next Minnesota State Legislative Session. Many of us have read the DNR OHV Regulations booklet, or a particular Minnesota statute, which is a law enacted by our State

Legislature. Laws by nature are not static, but dynamic. What seemed perfectly logical and a norm at one time may very well be out of place and irrelevant today.

As an ATV MN member, you are invited to attend this meeting. **You have a voice, working through an ATV MN member club.** The club can send in a resolution to the ATV MN office to have it read, discussed, and voted on at the Summit, to move it forward as a priority resolution.

Many resolutions are read and discussed during the meeting. As a collective group, we prioritize the ones we want our lobbyists to spend the most time on during the next Legislative Session. Your club’s resolution may or may not have majority support of the larger group and make the priority cut. Your idea may be a good one but the timing may not be right, or more information may be needed, so your resolution may be “tabled” or discussed again later.

Upon adjournment of the Legislative Summit, the priority resolutions will be in the hands of our capable lobbyists, who will move them forward at the State Capitol. The bills require sponsors within the Legislature, and go through many steps in the hope of becoming law. Ray

and Tom may ask you to come to a committee hearing, where Legislators may ask you about the need for the new law or appropriation of funds.

If all goes as planned, upon passage of the ATV MN bills into law, you should feel proud that you were part of the Legislative process. You enacted change and participated in the democratic process. You helped create a positive future for ATV recreation in Minnesota...and reached the height of the Legislative Summit.

2022 Trail Grant Application
INSTRUCTIONS**

STOP Before completing this application read and study the program manual, all information on the program website, and these instructions.

APPLICATION DUE DATE: February 25, 2022

COMPLETING THE APPLICATION:

- Carefully review the Project Eligibility section of the program manual to understand the different requirements and eligible expenditures and tips in the How To Apply section.
- Type all responses within the blank boxes associated with each question. Do not type your answers in the same box as the question. For location and site maps, you may insert these as separate pages immediately following each question and follow color coding system.
- Enter county Property (Parcel) Identification Number (PIN) of parcel(s) where project is located.
- Replace the sample resolution page with the actual approved resolution.
- DO NOT change the format of this document.
- Respond to all the required questions and provide all required documents, including those outlined in the Attachment Checklist. Failure to complete the application appropriately will mean that the project will not be considered for funding.
- Please keep answers as brief and concise as possible, but thoroughly answer all parts of a question. Answers should focus on the project for which the funds will be utilized and less on future phases (if applicable) of your project.

2022 Federal RTP Grant Application Is Now Available On The DNR Website

Tips:

- Plan far ahead to meet Feb 25 deadline.
- Include letters of support.
- Support letters from ATV MN permitted.
- If application is for a multi-use trail, know that it is for the life of the trail.
- Read information carefully related to the "Buy American" details.
